**Ref: Bid No. 02/RFB/2024 - Procurement of vehicles - Amendment No. 2 to the Bidding Documents**

Based on the provisions of Clause 8. Amendment of Bidding Document in Section I. Instructions to Bidders of the Bidding Documents, the present Amendment No. 2 is issued.

Under this Amendment it is agreed that:

### Article 1

In Section II - Bid Data Sheet (BDS), chapter C. Preparation of Bids, clause ITB 14.6:

*"Prices quoted for each lot (contract) shall correspond at least to 100% percent of the items specified for the lot (contract).*

*Prices quoted for each item of a lot shall correspond at least to 100% percent of the quantities specified for this item of a lot.*

*An incomplete bid for less than 100% of the items specified for a lot or for less than 100 % percent of the quantities specified for an item of a lot shall be rejected."*

**is hereby modified and shall be read** as follows:

*"Prices quoted for each lot (contract) shall correspond at least to 25% percent of the items specified for the lot (contract).*

*Prices quoted for each item of a lot shall correspond at least to 25% percent of the quantities specified for this item of a lot."*

### Article 2

In Section II - Bid Data Sheet (BDS), chapter E. Evaluation and Comparison of Bids, clause ITB 34.2(a):

*"Bids will be evaluated by item and the contract will comprise the item awarded to the successful Bidder."*

**is hereby modified and shall be read** as follows:

*" Bids will be evaluated for each item (vehicle) and the Contract(s) will be awarded to the successful Bidder(s), and will comprise the combination of the quantities of , up to the total quantity of 12 vehicles, which will result into the total lowest evaluated cost to the Purchaser for the combined quantities, as quoted."*

### Article 3

In Section II - Schedule of Requirements , chapter E. Evaluation and Comparison of Bids, clause ITB 41.1:

"41.1 Subject to ITB 38, the Purchaser shall award the Contract to the Bidder offering the Most Advantageous Bid. The Most Advantageous Bid is the Bid of the Bidder that meets the qualification criteria and whose Bid has been determined to be:

- (a) substantially responsive to the bidding document; and
- (b) the lowest evaluated cost.

Contract award and signing is subject to the Ministry of Environment, Waters and Forests being successful and being allocated funds through the „Program on reducing greenhouse gas emissions in transport by promoting non-polluting and energy-efficient road transport vehicles 2020-2024”, generically called “RABLA PLUS”, which ends on 25<sup>th</sup> of November 2024.”

is hereby modified and shall be read as follows:

In Section II - Schedule of Requirements , chapter E. Evaluation and Comparison of Bids, clause ITB 41.1:

"41.1 Subject to ITB 38, the Purchaser shall award the Contract to the Bidder offering the Most Advantageous Bid. The Most Advantageous Bid is the Bid of the Bidder that meets the qualification criteria and whose Bid has been determined to be:

- (a) substantially responsive to the bidding document; and
- (b) the lowest evaluated cost to the Purchaser, for the combined quantities offered for the item.

There may be awarded more than one contract to more than one bidder.

In determining Bidder or Bidders that offer the total lowest evaluated cost to the Purchaser for the combined quantities quoted for the items (vehicle) of the lot, the Purchaser shall apply the following steps in sequence:

- (a) evaluate individual items to determine the substantially responsive Bids and corresponding evaluated costs;
- (b) apply to the evaluated costs listed in a) above, any applicable discounts/price reductions offered by a Bidder based on the discounts and the methodology for their application offered by the respective Bidder;
- (c) rank the substantially responsive Bids starting from the lowest evaluated cost for the item considering any applicable discounts/price reductions; and

(d) determine the contract(s) award on the basis of the combination of the quantities of the items (vehicles) that offer the total lowest evaluated cost to the Purchaser.”

**Article 4**

In Section VII - Schedule of Requirements, chapter **Technical Specifications**, in the Table 1 with the **Minimum technical specifications**, the following specifications:

In Section II - Bid Data Sheet (BDS), chapter **D. Submission and Opening of Bids**, clause ITB 22.1, the provision:

*“The deadline for Bid submission is:*

*Date: 30<sup>th</sup> of September, 2024.*

*Time: 11.30 a.m., local time”*

is hereby modified and shall be read as follows:

**“The deadline for Bid submission is:**

**Date: 07<sup>th</sup> of October, 2024.**

**Time: 11.30 a.m., local time”**

## Article 6

In Section II - Bid Data Sheet (BDS), chapter D. Submission and Opening of Bids, clause ITB 25.1, the provision:

*"The Bid opening shall take place at:

is hereby modified and shall be read as follows:

*"The Bid opening shall take place at:

City: Bucharest  
ZIP/Postal Code: 010233  
Country: Romania  
Date: 07<sup>th</sup> of October 2024.  
Time: 11.30 a.m., local time"*

All the provisions of the Bidding Documents, Procurement of vehicles, 02/RFB/2024, which are not contrary to the provisions of this Amendment, remain unchanged.

### Important Note!

Bidders will amend and specify the quantities of the items (vehicles) offered and also the Models, in the Price Schedule Tables in Section IV - Bidding Forms, as part of their bid documents. Each Bidder may offer more than one model for the requested technical specifications.
