Dear colleagues,

The Ministry of Environmental Protection and Natural Resources of Ukraine presents its compliments to the Ministry of Environmental Protection, Water and Forests of Romania and informs on following.

On December 23, 2024, the Ministry decided to initiate a transboundary environmental impact assessment for the proposed activity by JSC «National Nuclear Energy Generating Company «Energoatom» «Construction and commissioning at affiliate SS «South-Ukraine NPP» site of Power Unit No. 4 with AP 1000 reactor, with the design capacity of 1,1 GWt, of Westinghouse Electric Company LLC (USA) manufacture».

According to paragraph 1 of Article 6 of the Agreement between the Cabinet of Ministers of Ukraine and the Government of Romania on the implementation of the Convention on Environmental Impact Assessment in a Transboundary Context, signed on November 18, 2022, in Bucharest, Romania (hereinafter referred to as «the Agreement»), we hereby submit to the Romanian Party the Notification of the proposed activity. Should the Romanian Party wish to participate in the transboundary environmental impact assessment procedure, we kindly request that the Ministry of Environmental Protection and Natural Resources of Ukraine be informed within 30 calendar days from the date of receipt of this notification in accordance with paragraph 4 of Article 6 and paragraph 2 of Article 8 of the Agreement.

The Ministry of Environmental Protection and Natural Resources of Ukraine takes this opportunity to reiterate its profound respect and highest consideration to the Ministry of Environmental Protection, Water and Forests of Romania.
