The Ministry of Environmental Protection and Natural Resources of Ukraine presents its compliments and informs you concerning the Transboundary Environmental Impact Assessment on the proposed activity «Operation of power units at the Rivne NPP».

The Ministry of Environmental Protection and Natural Resources of Ukraine were finished of transboundary consultations with Affected Parties in compliance with Article 5 to the Espoo Convention and in accordance with an national procedure, SE «National Nuclear Energy Generating Company «Energoatom» issued an conclusion on environmental impact assessment № 21/01-201812976/1 from 11 November 2024 regarding the proposed activity «Operation of power units at the Rivne NPP».

Guided by the provisions of paragraph 1 of Article 6 of the Espoo Convention, according to which the parties shall ensure that the results of the environmental impact assessment, including environmental impact assessment documentation, as well as comments on this documentation, are duly taken into account in the final decision on the proposed activity, which received in accordance with paragraph 8 of Article 3 and paragraph 2 of Article 4, and the results of consultations specified in Article 5, when preparing the conclusion on the environmental impact assessment for the specified proposed activity, the Ukrainian side duly took into account the results of the transboundary environmental impact assessment by setting out the environmental conditions for the implementation of the proposed activity.
