Dear colleagues,

The Ministry of Environmental Protection and Natural Resources of Ukraine presents its compliments to the Ministry of Environmental Protection, Water and Forests of Romania and informs on environmental impact assessments of the proposed activity «Construction of power units 5 and 6 with AP1000 reactor unit at the Khmelnytskyi NPP site».

On December 03, 2024, JSC «National Nuclear Energy Generating Company «Energoatom» uploaded the Environmental Impact Assessment Report (herewith – the EIA Report) regarding the proposed activity «Construction of power units 5 and 6 with AP1000 reactor unit at the Khmelnytskyi NPP site» to the Unified Environmental Impact Assessment Register.

Since the Romanian side has declared its intention to participate in the environmental impact assessment procedure, in accordance with paragraph 1 of Article 7 of the Agreement between the Cabinet of Ministers of Ukraine and the Government of Romania on the implementation of the Convention on Environmental Impact Assessment in a Transboundary Context done at November 18, 2022 in Bucharest, Romania (herewith – the Agreement), we submit the EIA Report on the proposed activity «Construction of power units 5 and 6 with AP1000 reactor unit at the Khmelnytskyi NPP site» to initiate public consultations and provide comments and suggestions. These inputs should be duly considered in the decision-making process regarding the proposed activity.

Please also take a note, that due to the threat to the security of critical infrastructure facilities caused by ongoing of Russia's aggression against Ukraine, in order to limit the dissemination of the JSC «National Nuclear Energy Generating Company «Energoatom» information on critical infrastructure facilities in public sources, as well as to ensure the reliable functioning of the integrated energy system of Ukraine under the Martial law legal regime, the confidential information on the geodetic information and technical system of critical infrastructure facilities, including geographic data in the geodetic information and technical system, has been excluded from the aforementioned EIA Report.

The Ukrainian side will be grateful for comments if any to the EIA Report within 45 calendar days in accordance with paragraph 2 of Article 7 of the Agreement.
